## Notes

(forming part of the financial statements)

### 1 General information

Brinefield Storage Limited is a private company incorporated in England, United Kingdom, under the Companies Act. The address of the Company's registered office is Natrium House, Winnington Lane, Northwich, Cheshire, CW8 4GW.

The financial statements are presented in pounds sterling, which is the Company's functional currency.

### 2 Significant accounting policies

#### Basis of accounting

The financial statements have been prepared in accordance with international accounting standards and in conformity with the requirements of the Companies Act 2006 ("Adopted IFRSs"). They have been prepared on a historical cost basis.

#### Financial instruments

Financial assets and financial liabilities are recognised in the Company's balance sheet when the Company becomes party to the contractual provisions of the instrument.

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. Financial liabilities are initially measured at fair value, net of transaction costs. Financial liabilities are subsequently measured at amortised cost, using the effective interest method. An equity instrument is any contract that evidences a residual interest in the asset of the group after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

### 3 Information regarding directors and employees

The Company had no employees during the current and preceding year.

### 4 Amounts owed to group undertakings

As at the balance sheet date amounts owed to group undertakings were £6,132 (2021: £6,132). The carrying amounts of these liabilities approximates their fair value. Amounts owed to group undertakings are non-interest bearing and are repayable on demand.
